Accomplishments



In 2010, The Joshua M. Freeman Foundation continued to increase awareness of the organization and to increase fundraising initiatives. The major project of the foundation continued to be its commitment to bring exceptional arts experiences to the Mid-Atlantic region. The Freeman Stage at Bayside, nestled near Fenwick Island, Delaware, welcomed nearly 25,000 people during its third season, which also brought our 50,000th visitor since our first season in 2008. Some of the region's most celebrated arts organizations, including the Delaware Symphony Orchestra, the Mid-Atlantic Symphony Orchestra, First State Ballet, and Clear Space Theatre Group dazzled our audiences once again under the setting sun. Thousands of patrons tapped their feet to the hits of yesteryear during our first ever Tribute Week. Children danced and sang along to the Dirty Sock Funtime Band, and were later amazed by our fireworks spectacular during the Labor Day Finale. We furthered our commitment to bring the arts for all to enjoy as we hosted over 2,000 local elementary school children this year with the launch of our arts outreach program.

Major accomplishments for the Joshua M. Freeman Foundation in 2010 included:

- The addition of a new board member, Sara Chase Carlson.
- Continuing to build a sustainable staff to support the mission, goals and objectives of the foundation. Doug Phillips, marketing manager and Debbie Werden, accounting manager joined the team in January 2010.
- Overall improved financial results see enclosed unaudited income statement.
- Growing fundraising revenue through level of giving program, brick paver program and annual golf tournament and Arts by the Sea.
- Receiving grant income for programming for The Freeman Stage.
- Further refining and improving the venue of The Freeman Stage including the opening of the Stage Café, perimeter fencing and entrance improvements, lighting and landscaping enhancements.
- Launching a specific outreach program for children and the underserved community. Over 2,000 school children attended the programs as well as seven other county organizations.
- Overall enhancement of branding of both the JMFF & The Freeman Stage
- Increased promotional efforts for The Freeman Stage
- Welcoming our 50,000th patron to The Freeman Stage in just three years.
- 345 new patrons registered in our database for future giving opportunities.
- The new utilization of other community venues to present performances in the off-season.
- Improved operational capacity and results at The Freeman Stage resulting in increased concession sales and ticket sales.
- 99.5% customer satisfaction rating from The Freeman Stage survey.








Joshua M. Freeman Foundation: Number of Donors Per Donation Category






Joshua M. Freeman Foundation Average Donation Contribution Per Donation Category






Joshua M. Freeman Foundation: 2010 Number of Donations Made Per Donor






2009 Year End Solicitation Donors By Freeman Stage Attendee
